Important OSHA Standards Contributing to Fewer Workplace Accidents



Standard 1910.132: Personal Protective Equipment: Protective equipment, including clothing, helmets, goggles and other eye protection, must be used when process or environment presents hazards. Electrical safety equipment or mechanical failures can cause deadly harm.



Standard 1910.147: Lock Out-Tag Out: Before any service or maintenance work is performed, the energy source must be locked out and tagged out to prevent the release of hazardous energy during the service or maintenance. The lockout/tagout procedure must be followed for all equipment that can be locked out and tagged out.



Standard 1910.119: Process Safety Management (PSM): PSM is a set of practices designed to prevent a major unplanned release of a highly hazardous chemical. OSHA estimates that 70% of workplace deaths and 75% of workplace injuries are preventable.

OSHA Inspections: OSHA inspectors conduct inspections to ensure that employers are following OSHA standards. Inspections can be initiated by OSHA, by a complaint from a worker, or by a complaint from a state or local government.

Process Safety Management Standard follow the concepts embodied in the OSHA training guidelines contained in this booklet The length and complexity of OSHA standards may make it difficult to find all the references to training So to help employers safety and health professionals training directors and others with a need to know OSHA s training related requirements have been excerpted and collected in this booklet Requirements for posting information warning signs labels and the like are excluded as are most references to the qualifications of people assigned to test workplace conditions or equipment It is usually a good idea for the employer to keep a record of all safety and health training Records can provide evidence of the employer s good faith and compliance with OSHA standards Documentation can also supply an answer to one of the first questions an accident investigator will ask Was the injured employee trained to do the job Training in the proper performance of a job is time and money well spent and the employer might regard it as an investment rather than an expense An effective program of safety and health training for workers can result in fewer injuries and illnesses better morale and lower insurance premiums among other benefits
